WHO IS ELIGIBLE

Applicants not attending Summer School: If you do *not* plan to enroll in Summer School and will continue to be a degree candidate at Georgetown in the Fall 2012 semester, the only financial aid you may be eligible to receive is Federal Work-Study.

Applicants attending Summer School at Georgetown: If you are currently enrolled in a degree granting or eligible certificate program at Georgetown and will register at least half time at Georgetown during the summer term you may be eligible to receive financial aid.

Applicants attending a summer Study Abroad Program or Study Away Program from Georgetown: If you are currently enrolled in a degree granting or eligible certificate program at Georgetown and will register at least half time in a Study Abroad Program or a Study Away Program from Georgetown during the summer term you may be eligible to receive financial aid.

APPLICATION REQUIREMENTS

Applicants not attending Summer School: You must file (or have already filed) a 2012-13 FAFSA.

Applicants attending Summer School: If you are applying for federal financial aid, you must submit a *Graduate Summer 2012 Financial Aid Application* and you must file (or have already filed) a 2011-12 FAFSA. If you are **only** applying for a Private Education Loan, you must submit a *Graduate Summer 2012 Financial Aid Application*.

APPLICATION DEADLINES

April 1, 2012: Applicants must complete a 2011-12 or a 2012-13 FAFSA, if applicable, and submit a *Georgetown Graduate Summer 2012 Financial Aid Application* by this date.

June 30, 2012: 2011-12 FAFSA must be filed before or by this date.

Student Financial Services will notify you via email when your summer financial aid award is available. Please be advised that you can monitor the receipt of your summer financial aid application as well as your financial aid award online via MyAccess.
